

**7CPHC March 2013  
Meeting Minutes**

**Meeting called to order at 7:18 PM**

**New Members and Guests:** Larry and Dana Klamecki attended as new members of our club. Virginia Salmina also attended as a new member of our club.

**Secretary's Report:** Minutes from our last meeting were reviewed and approved by the membership in attendance.

**Treasurer's Report:** Our Treasurer's report was unavailable as our Treasurer could not attend our meeting. Denise did let Diane know that our club's insurance premium for both the Open and CCC programs was received and she will pay the premium for both groups this month.

We are offering lower prices and package discounts. \$850 prepaid will include 1 stall, all APHA classes for both shows plus all APHA, Drug, and CCC fees. Awards will be given to 3<sup>rd</sup> place for classes and 4<sup>th</sup> place for the show. Halter classes are running a special deal as well. If Halter classes have 6 or more exhibitors, the exhibitor capturing 6<sup>th</sup> place will get the class entry at no charge.

**Open Report:** The 7CPHC Open and Sun Coast Pinto Breed show will be held on May 4<sup>th</sup> and 5<sup>th</sup> at Watsonville Fairgrounds. Show information and premiums will be posted on both club's websites and the forms will be mailed out to everyone this week.

**Old Business:** Diane reminded us that members need to attend 4 meetings and work 6 hours to satisfy our year-end award requirements. Someone asked Diane how many meetings and work hours were needed to satisfy our year-end awards requirements and thought it was 6 meetings vs. work hours.
