

## **7CPHC Meeting Minutes May 13, 2008**

Meeting called to order at 7:03 pm

Motion to approve April minutes: None to approve.

**Treasurers Report:** OPEN Chkg: \$3,090.56 Savings \$6,996.67  
CCC Chkg \$1,590.75 Savings \$1,686.18

**Youth Report:** the fundraisers will be tail bags and Sunday June 1<sup>st</sup> will be a trailer wash  
at Melissa's house. Cost is \$20 for outside and \$10 for inside of trailer. Kelly's farm will  
also be making horse cookies.

**CCC Report:** Horseman of the year is coming up and we need to have nominees  
submitted by August. If you know of someone that you would like to nominate, write a  
bio and submit to Diane. CCC is talking with APHA to see about having our own zone  
show. We are requesting the zone show with Arizona. We were trying to get the APHA  
directors to come to the awards banquets for different clubs and the CCC reps all opposed  
it.

**New Business:** The open show was a good show. There was a good turn out with about  
55 horses as opposed to last show with about 75 horses. Thanks to everyone who helped.  
The next show is June 8 and we need an announcer for that show. There is a pinto show  
this weekend at Woodmyst (May 18) Must bring pinto papers. If your horse is not a  
registered pinto, there will be someone there to help with registration.  
The CCC April show after expenses brought home about \$37,000. When all checks clear  
it will be put into the joint account. There will be a more detailed accounting balance next  
month.

Clarification is needed on open program year end awards categories. Leadline, 10 &  
under, 13 & under, 14-17, A/A 34 & under, A/A 35 & over, Open, Open English, Open  
Western, Halter, Reining, and Rookie of the Year are all listed in the 2008 rules.  
We will check into the rules from 2007 about awarded categories for year end awards and  
will be readdressed at next meeting.
