SCPC & 7CPHC Show Rules

1. *Current PtHA rules apply for all Pinto classes.*
2. *Current West Coast Show rules apply for all Open classes.*
3. *Judges decision is final.*
4. *Owners/riders must have copies of their current amateur card, breed affiliation membership/amateur/WT cards and registration papers as appropriate.*
5. *Copy of horse registration must be presented when picking up numbers.*
6. *All owners/riders competing for SCPC/7CPHC Year End Awards Programs are required to be current members of 7CPHC and/or SCPC and PtHA. Those interested in joining at the show, a membership packet is available in the office.*
7. *There will be a \$100 office fee for all returned checks.*
8. *All dogs on show grounds must be on a leash.*
9. *A three minute gate call will be strictly enforced.*
10. *Juniors may not show stallions.*
11. *SCPC/7CPHC has the right to cancel or combine any classes due to lack of participation.*
12. *Unsportsmanlike conduct will not be tolerated. Any disruptive or dangerous behavior is grounds for being excused and/or removed from the show.*
13. *SCPC/7CPHC will follow State of California rules with regards to drugs and drug testing. Drug forms will be available in the office to declare any medications prior to the show.*
14. *Proper attire is required for all classes. A safety ASTM/SEI certified helmet is required to be worn for all English classes. West Coast Show Rules apply for Western classes.*
15. *There will be a one-time \$10 trail obstacle fee for all who enter a trail class. There will however, not be a time limit on your warm up time.*
16. *Classes must be added or scratched at least three classes prior to the class you wish to change. Tack changes must be reported to the gate two classes prior before change is required.*
17. *A representative will be available on site during the April 18th, 2015 show to register all horses needing PtHA registration. The papers must be obtained and completed prior to entering a PtHA class.*
18. *Separate checks are required for each club registration.*
